

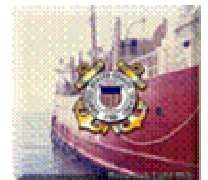

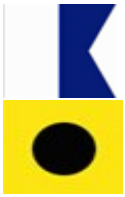

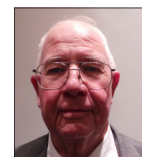

SEA STORY FROM OUR PAST

The first tour of duty of Nantucket Lightship #112 Station January 15, 1946 at the end of World War II. At 1:30 pm left Chelsea Coast Guard Repair, Mass.

My very first time at sea and I was scared to death and fascinated at the same time as being in this new worldly adventure. Did not have a watch that night, but did have the 8-10 am the following day. The crew, including myself, were all in and out of our bunks with bouts of seasickness. Somehow mine started to subside by the time my watch came up by 8 am that morning. When I arrived on the Flying Bridge I was so surprised in this new world of nothing but sea and more sea without seeing any land. I felt so tiny.

I was told by the executive officer Bos'n to take the ship's wheel and keep it on course that would be our scheduled exact position of our duty station where we would proceed with the dropping of our anchor to hold us secure to that position for aiding the endless trafficking of increased troop ships to New York and Boston at the war's end.

This was a big change in the way I would live my life from that day on. I had been told by the captain and instructed how to keep the ship's log and fly all storm warning flags from our mast. Would receive storm warnings from radio weather station daily. I felt a lot of responsibility and how important it was and how I handled it. I would bring the reports to the Yeoman in charge for the Captains report of the month. The logs and my quarter-master duties became very much routine after awhile. The one job I feared the most was when I would go on the blinking light for signaling information between ships. Practiced very hard and finally got it down, but at a very slow pace. We were all divided into work details for different work stations. We all had been assigned at times as mess cooks in the galley for certain periods of time.

My first watch on the bridge, January 16, 1946, 8 am- 10 am.

B/M 2nd Frank Prikyl as the executive officer on board, he would give us and direct us in all jobs pertaining to the functioning of our duty. We were very aware of what was expected of each of us for this duty tour on board. After getting squared away on the ship and still with the sea sickness that was still with us, we were also getting our sea legs and were able to walk with balance on the deck.

I was assigned to mess cook for one month starting 1/19/1946 at 7 am. Made my own breakfast and enjoyed it after the sea sickness had left me feeling quite good. The weather has cleared up and the sea seems to have settled down to a moderate chopping or less pitching and rolling. Seems that I've got used to it with my body movements. Work as a mess cook is routine as you go through the day with your routine jobs that the cook assigns you. I've still maintained my making out the daily log and Q/M duty.

My second month I was assigned to work details, which involved all phases of maintenance aboard ship. All these duties will change as we get in the storm season bringing with it all sorts of weather mostly coming out of the Nor Eastern storm that are of hurricane velocity. there are time when all you can do is get in your bunk and hold on for dear life. These storm seem to have come on us at the day of January 18. With a group of five storms back to back with us going on no work details and scarce galley chow, such as sandwiches. We got used to the bad weather and inconveniences very quick. The one thing that any of us could not take was the introduction of the Fog horn, that would go on for extended periods. There was a period of time needed to adjust to noise and actually the shaking feeling that goes along with it. Going outside on the deck was forbidden for ear damage danger. After awhile you let it be part of your daily routine.

The hardest to overcome was to be able to sleep though it, but even that came after a while. Believe, the month of January, we had over 10 bad N.E. storms and one with hurricane velocity on February 7. B/M Prikyl called Seaman Thomas and myself to tie down a davit that had broken loose on the forward bow of the ship and had to be secured. The Bos'n prepared us with life lines secured to the deck before attempting our job of securing the davit. The storm was in the early stages, but still rolling to some degree. We both worked together and secured the davit and were working our way back to safety when all of a sudden a huge wave put her in roll of water came over both of us but not enough to was us overboard. Thanks to Bos'n Prikyl and his knowledge, both Thomas and I escaped going overboard. I remember how I felt when I logged it into our ships log.

Bos'n Prikyl was a regular Coast Guard member making a career out of it by joining at an early age. He had all the skills required to have mastered seamanship aboard any vessel he was aboard. I respected him and asked him for guidance many times. He supplied me with material and tools to make a traveling small sea bas as a project for me to do during idle time. He taught me how to make a Masthead Knot used in the early sailing days of shipping. Bos'n has shaped my life in so many ways. Getting close to the end of the month, meaning my galley mess duty would end and I would go on daily work details. This scheduling change made me happy and did not fell like a waiter no longer.

We have experienced a few snow storms and the removal of snow and ice from the decks and railing. Never a dull day on this old Nancy, a new nickname, the crew is calling the ship. Seems like we are caught in a series of bad storm conditions. There was one day I remember that was so different than any day I remember, the seas were very calm and a slight breeze. These would change rapidly around noon, February 15. A full scale Nor'Eastern with hurricane velocity arrived with all of its fury by noon that day. Our ship was rolling at 45-50 degrees, when she changed position and went bow into the storm. Thought our anchor chain was going to break any minute. At around 5 pm was trying to eat a sandwich and the ship went into what seemed to be a double wave roll and put me airborne and sliding across the galley mess table to an abrupt end into a structural part of the bows construction. Was still conscious but bleeding badly, the pharmacist mate cleaned me up and dressed the wound. I'm just glad that it was not worse. Had a headache after it was over and was told to stay in my sack for awhile and rest. They opened the ships exchange locker for us to buy cigarettes at 50 cents a carton.

We were all waiting anxiously for the buoy tender Hornbeam to take us aboard and put us ashore at New Bedford, Mass. There we would board trains home for our 30 day leave. The Hornbeam brought with them a Life Magazine film crew to do an article about our ship being the first Lightship back on station since the end of World War 2. A few of them had gotten sea sick and were having a bad time of it and were just hanging on. Very fortunate there was a crew member who was a professional photographer and was very helpful to them. The Life Magazine was published June 1946.

Completed my leave and was sent to Brooklyn, N.Y. for discharging. At this time was a seaman 2nd class. I am very proud of the over 40 years of experiences received as being a part of U.S. Coast Guard.

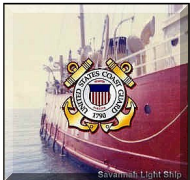
VETERANS AFFAIRS

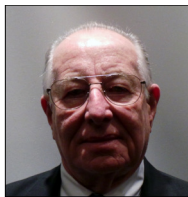
We have published the reunion notice in various publications that will be appearing throughout the summer. Hopefully we will get the good results that we did last year from these publications.

The USCG Lightship Sailors Association International is a Delaware Corporation, incorporated on January 4, 2007 and recorded in Sussex County, DE. Follows a condensed explanation.

"The corporation is organized exclusively for charitable, educational and scientific purposes under Section 501 (c) (3) of the internal Revenue Code....., may engage in any lawful act or activity for which corporations be organized under the General Corporation Law of Delaware.

This corporation shall be a non-profit corporation.

Upon dissolution of the corporation, its assets shall be distributed for one or more exempt purposes under Section 501(c)(3) of the Internal Revenue Code, **or shall be distributed to the federal government or to a state or local government for a public purpose**" {editors emphasis}.

Further

"The conditions of membership of the corporation are as stated in the by-laws of the corporation".

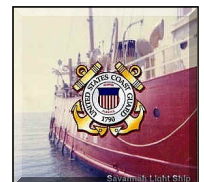
