To all our Brother Lightship Sailors, Members and Friends:

Please take a moment to complete the annual membership form on page 5, and return it to Jay McCarthy. We need and appreciate your annual dues to support the operation of the organization.

As I mentioned in the last edition of The Fog Signal, Bob Gubitosi and myself visited Lewes DE in early September on a fact finding trip. While in Lewes we had an opportunity to inspect a building that we considered adequate for our museum, if it could be acquired (please see page 2). This building was subsequently and informally offered to The Overfalls Foundation (OMMF), but their Board felt that, for a variety of reasons, they could not take on the building at this time. The Overfalls Foundation's Board then expressed a desire to see this building go to The LSA and will do what they can to support making this happen. I will be in Lewes in February and am expecting to formalize the arrangement and take title to the building in the name of The LSA at that time.

Please keep in mind, there are many details to work out including having the building moved, repairs and funding. I will keep you abreast of developments as they occur.

Please start making your plans to be in Lewes in October, 11, 12, 13 200 We are planning a ribbon cutting ceremony where the Governor of Delaware will be presiding. The Director of Tourism for the State of Delaware will be traveling to Colorado in early January to work out some details of our move to Lewes and the establishment of our museum and the ribbon cutting.

Please, Please plan on being present. This is a truly a historic event in the history of The LSA, we want all of our members to share in the event.

#### MEMBERSHIP ... Third Annual Dues Renewal Notice ...

It's hard to believe that a year has passed since the mailing of our second *Annual Dues Renewal Notice*. Many members responded to that mailing with their dues payments, and quite a few were most generous in sending in donations to be applied either to our general fund or to Lightship Preservation. Thank you for your most appreciated generosity.

As we all know, the Mission Statement for the Lightship Sailors Association, Inc. is to preserve Lightship History and Lightships. Dues renewal has a very intricate part in helping to uphold this Mission Statement, and to assist in keeping this organization alive and functioning. Expenses (just like at home) keep increasing, and we need everyone to do their part.

In order to continue our improvements and make the LSA more open to all Dues paying members. We have made some changes for 2007.

#### Dues ... there are (3) three Levels of LSA Membership:

Dues are to be paid with the submission of this application. Below are the current dues structures as voted upon by the Board of Directors in July 2005 and by the General Membership at the Annual Reunion in Portsmouth, VA in October 2005 and updated at our Annual Reunion in Seattle, WA in October 2006.

#### **FULL MEMBERSHIP LEVEL:**

#### Annual Dues \$25.00 per year.

#### **USCG Lightship Sailor Veteran**

The applicant certifies with this application that he is a Military Discharged USCG Veteran who served as part of the ships company on a commissioned Lightship of the U. S. Coast Guard.

#### LSA Member

Other USCG Veterans, family members, friends, and anyone that has an interest in Lightships, the men that sailed on them, Lightship history and its preservation.

Both of the above categories, USCGLSVeteran and LSA Member, will pay the same \$25.00 Dues and share the same responsibilities. This includes having the opportunity to be heard and vote on all matters that come before the general membership, be part of a committee, in addition can be nominated and voted onto a Board of Director position. There will be NO distinction between the two categories, other than their titles. USCG LSVET title, provides a tool to help us track and identify USCG Lightship Sailor Veterans. Note: \$5.00 from each \$25.00 Dues Payment made is designated for Lightship Preservation.

#### GROUP / BUSINESS Member LEVEL; Annual Dues \$50.00 per year.

Join as a Group or Business, limited to (1) one vote per Group / Business, pertaining to official business conducted during the General Membership Business Meeting. This level was updated and voted on by the BOD and General Membership at the Annual Reunion in Seattle, WA in October, 2006.

#### LIFE MEMBER LEVEL;

#### \$300.00 ... this is a one time, Life Time Fee

Any USCG Lightship Sailor Veteran or LSA member may purchase this Lifetime Membership.

Newest Paid Level, as voted on by the BOD and General Membership at the Annual Reunion in Seattle, WA in October, 2006.
