





The Library Corner by Jay McCarthy with Pete Marx



#### MORE ON FILING A CLAIM FOR VA BENEFITS

I have already gone over hearing loss and tinnitus claims, here are a few more medical conditions that do effect some of our members:

If you went to sick call or the hospital while on active duty, list it when you file, the worst thing that can happen is that the

VA will deny your claim for lack of evidence. There are many medical problems that can be related to active duty even though some times years pass before they appear.

A few examples are:

Asbestosis, most often this condition will not appear until some times twenty or more years. You have to show that you were exposed, for any below deck ratings this is of course easier, but we all know that especially when a ship goes into dry dock there is asbestos dust through out the ship.

M.S., the symptoms have to be within seven years of your discharge, but if you can prove with doctors statements and/or medical records, then you can not be denied. An example would be a history of frequent head aches, etc.

Remember, the laws concerning disabilities are constantly changing; an example is Agent Orange causing diabetes type II, lung cancer, etc.

#### LIMITED INCOME:

If you have health and/or financial problems and are just getting by on a limited income, you can file for a non-service pension, (this also applies to widows). There are a lot of deductions that can be applied such as medical expenses, etc.

It is best to go through a Service Representative as they have to be certified yearly and will act in your best interest.

"The VA is not a charity", these benefits are what you have earned and deserve if they apply to you. I will list a couple of web sites that can be invaluable in filing:

## A Little Trivia ?

When was the last time the US Coast Guard hung anyone?

Was it in the 1700's, 1800's or 1900's?

How about on August 17, 1928 at 06:04am;

Horace Alderman was "hung" at the US Coast Guard Station at what is now known as the Bahia Mar Marina in Ft. Lauderdale, Broward County, Florida. Alderman, a rum runner during Prohibition days in the 1920's, was smuggling a boatload of booze into Florida from the Bahamas when he was intercepted by a Coast Guard Cutter. In the ensuing shootout he killed three men. A Federal judge sentenced the Gulf Stream Pirate to death by hanging in the County seat of the County he re-entered on his return to the United States. Broward County had no idea about how to hang a murder, so the unhappy task was palmed off on the Coast Guard.
